
Campuses

English Language

On Arrival

When you arrive at the university to commence your studies you will be invited to register. This is a two part process.

Part 1: Online Registration: Requires you to log in to the university portal and go through an online process to verify information about yourself and your new programme of study. In order to start Online Registration, you will need your portal login details. These will be emailed to you or your agent nearer the start date of your programme when you have completed all stages of the admissions process. You will also be given a summary of the balance of your first year's tuition fees less any payments including the pre-registration deposit and any discounts.

To complete your registration, you will need to pay at least 50 per cent of this amount. This amount can be paid during online registration by entering credit/debit card details. Alternatively you can transfer the payment to the university's bank account or pay directly to the Student Centre

The remaining balance of tuition fees for September starters will be due before the last Friday in January and for MARIV starters before the last Friday in May. A 5 per cent discount is available on your tuition tees in full before the end of September (for those registering (poseptember programmes) or the end of January for those registering on January
