In conformity with Supreme Court judgments and directions, UGC guidelines and State Government Instructions are following 'Zero Tolerance Policy' towards ragging any student of Bharat Institute of Technology on accused and found guilty of ragging, will be severely dealt in accordance with the provisions of the law.

Ragging in all its forms shall be completely banned in this Institution including in its departments, constituent units, all its premises (academic, residential, sports, kiosks and cafeteria) whether located within the campus or its outside and in all means of transportation of students whether public or private. The Institution shall take strict action including but not limited to criminal proceeding and /or cancellation of admission against those found guilty of ragging and /or of alleged ragging and subject to circumstances, the burden of proof may lie on the perpetrator of alleged ragging and not on victim. The university is bound by UGC regulations on curbing the means of Ragging in Higher Education Institutions 2009 dated 17 June 2009, as gazetted on 4 July 2009 and the amendments there from time to time.

Vision

To build a ragging free environment by instilling the principles of democratic values tolerance, empathy, compassion and sensitivity so that students become responsible citizens.

Mission

To create an atmosphere of discipline by passing a clear message that no act of ragging in college premises.

Objectives:

- To bring out an awareness among the students about consequences of ragging.
- To keep a constant eye and vigilance over ragging so as to prevent its occurance.
- To address any ragging issues immediately and take action as advised by the committee.
- To assist and make the new entrants comfortable & to provide holistic environment.
- To initiate appropriate measures to prevent any untoward incident of ragging before it raises its ugly head.

Anti-Ragging Policy

According to the UGC Regulation on Curbing the Menace of Ragging in Higher Institutions, 2009, ragging constitutes one or more of any of the following acts:

- 1. Any conduct by any student or students whether by words spoken or written or by an act which has the effect of teasing, treating or handling with rudeness a fresher or any other student.
- 2. Indulging in undisciplined activities by any student or students which causes or is likely to cause annoyance, hardship, physical or psychological harm or to raise fear or apprehension thereof in any fresher or any other student.
- 3. Asking any student to do any act which such student will not in the ordinary course do and which has the effect of causing or generating a sense of shame, or torment or embarrassment so as to adversely affect the physique or psyche of such fresher or any other student.
- 4. Any act by a senior student that prevents, disrupts or disturbs the regular academic activity of any other student or a fresher.
- 5. Exploiting the services of a fresher or any other student for completing the academic tasks assigned to an individual or a group of students.
- 6. Any act of financial extortion or forceful expenditure burden put on a fresher or any other student by students.
- 7. Any act of physical abuse including all variants of it: sexual abuse, homosexual assaults, and stripping, forcing obscene and lewd acts, gestures causing bodily harmer any other danger to health or person.
- 8. Any act or abuse by spoken words, emails, post, public insults which would also include deriving perverted pleasure, vicarious or sadistic thrill from actively or passively participating in the discomfiture to fresher or any other student.
- 9. Any act of physical or mental abuse (including bullying and exclusion) targeted at another student (fresher or otherwise) on the ground of color, race, religion, caste, ethnicity, gender (including transgender), sexual orientation, appearance, nationality, regional origins, linguistic identity, place of birth, place of residence or economic background.

Punishments

According to the UGC Regulation on Curbing the Menace of Ragging in Higher Educational Institutions, 2009, depending on the nature and gravity of the guilt established by the Anti-Ragging Squad, those found guilty may be awarded one or more of the following punishments, namely;

- Warning, writing apology letter.
- Suspension from attending classes and academic privileges.
- Withholding/with drawing scholarship/fellowship and other benefits.
- Debarring from appearing in any test/ examination or other evaluation process.
- With holding results.
- Debarring from representing the situation in any regional, national or international meet, tournament, youth festival, etc.
- Suspension/expulsion from the hostel.
- Cancellation of admission.
- Rustication from the institution for period ranging from one to four semesters.
- Expulsion from the institution and consequent debarring from admission to any other institution for a specified period.

In case the person is unwilling to appear in self/grievances may be dropped in writing at the letterbox/ suggestion box of the grievance cell at administrative block.

Objective:

The objective of the Grievance cell is to develop a responsive atmosphere and accountable attitude among all the stakeholders to maintain a harmonious educational atmosphere in the institute.

A Grievance cell should be constituted for the redressal of the problems reported by students of the college with the following objectives:

- Upholding the dignity of college by ensuring a strife-free atmosphere in the college through
 promoting cordial student-student relationships and student teacher relationships etc.
 Encourage students to express their Grievances/ problems freely and frankly, without the fear
 of being victimized.
- 2. Advising students of the college to respect the right and dignity of one another and show utmost restraint and patience whenever any occasion of rift arises.
- 3. Advising all staff to be affectionate to the students and not behave in a vindictive manner towards any one for any reason.
- 4. Ragging in any form is strictly prohibited inside and outside the institution. Any violation of ragging and disciplinary rules should be urgently brought to the notice of Principal.

MECHANISM FOR REDRESSAL OF GRIEVANCES OF STUDENTS AND STAFF

The students are themselves stakeholders in any institution imparting education, and we endeavor to make all efforts to ensure transparency in all the activities at different stages. Taking this spirit into consideration the institute has decided to provide a mechanism to students for Redressal of their grievances as protection of human rights is essential for the all-round development of an individual's personality. To realize the primary needs of the students, staff and secure civil liberties for everybody, a Grievance Redressal Cell has been constituted. The cell is indented to find solutions for all kinds of grievances as mentioned in UGC regulation.

The Grievances may broadly include the following complaints from aggrieved students

- Academic grievances that include complaints related to classroom teaching, classroom management and completion of syllabus.
- Non-Academic grievances such as discipline issues, any kind of physical or mental harassment, etc.
- Grievance related to Assessment that includes complaints on delay in declaration of results, non transparent or unfair evaluation process, etc.
- Grievance related to Victimization that includes complaints on alleged discrimination of students from backward castes, women and minority sections.
- Grievance related to Attendance that includes complaints regarding improper maintenance of student attendance records.
- Grievance related to Charging fees that include complaints on demand of money in excess
 of that specified in declared admission policy or approved by competent authority to be
 charged by the institution.
- Grievance regarding conducting of Examinations includes complaints regarding delay in conduction of examinations beyond that specified in academic calendar.

The aggrieved student will submit the application of Grievance or appeal to the Institute level committee, through the, grievance cell faculty members or Head of Departments addressing to the Head of Institute (Chairman of grievance committee) concerned.

Procedure for lodging complaint:

- 1. The students may feel free to put up a grievance in writing /in the format available in the admin dept. and drop it in inboxes.
- 2. The Grievance Cell will act upon those cases which have been forwarded along with the necessary documents.
- 3. The Grievance Cell will assure that the grievance has been properly solved in a stipulated time limit provided by the cell.
- 4. The Grievance cell member after verifying the facts will try to redress the grievance within a reasonable time.
- 5. If the student is not satisfied with the verdict or solution of the concerned faculty member, then the same should be placed before the total Grievance redressal committee.
- 6. The Chairman of the Institute grievance committee, after verifying the facts and the papers concerned and discussing with the committee members will place the matter in meeting or shall pass appropriate order in the best possible manner within a reasonable time.
- 7. The committee at all levels will observe the law of natural justice and hear the complaint and concerned people.
- 8. The relevant provisions of the Act/ Regulations shall be kept in mind while passing an order on any Grievance at any level and no such order shall be passed in contradiction of the same.


